### Reflexive input

Please use the following list of prompts as a guidance for your reflexive input in Part II. Pick some of the prompts that speak to you most; please be as concrete as possible in talking about how the factors mentioned in the prompts shape your own knowledge production and experience as a researcher and academic.

#### Individual

- 1. What is my role as an embodied individual in knowledge production?
- 2. What is my positionality, what are my biases?
- 3. (How) do I collaborate? What is the role of interaction and collaboration in my field, how does it shape knowledge?

#### Institutions and infrastructures

- 1. In which knowledge infrastructures do I work? On the micro, meso, macro level?
- 2. How do the frameworks of academia/the university affect knowledge production?
- 3. What are the technological infrastructures involved: digital and physical systems, networks, platforms...
- 4. How do the specifics of my discipline inform knowledge production?

## Locality

- 1. What are the specific contexts and locations where knowledge is produced?
- 2. How does space and location affect knowledge production?
- 3. How do I consider spatial contexts and local perspectives (the traditional role of area studies)?
- 4. How does it challenge the notion of abstracted, universalized truths?

### Wider contexts

- 1. Which 'external' social, institutional, political, economic, ... factors affect and influences the research process and outcomes?
- 2. How do languages inform or limit knowledge production, both for the researcher and the object of research?
